ORDER:-

The Secretary, Tamil Nadu Electricity Regulatory Commission in the letter second read above has stated that in G.O.Ms.No.80, Energy (A1) Department, dated: 19.8.2002 regular staff for the Tamil Nadu Electricity Regulatory Commission was sanctioned. Among others, the Government accepted in principle to sanction two posts of Deputy Director each for Director (Engineering) and Director (Tariff) and initially sanctioned one Deputy Director (Engineering) and Deputy Director (Tariff). It was also ordered that depending upon the need, the Commission may consider opening the second post of Deputy Director for Engineering and Tariff.

He has further stated that taking into consideration the increased workload, another person in Post Graduate degree in Commerce or Chartered Accountant or Cost Accountant or MBA in Finance is necessary for determination of the tariff for generation, supply, transmission & wheeling of electricity, scrutiny, revalidation & reality check of data furnished by the licensee in their Aggregate Revenue Re-quirement for every financial year. The Commission desires to open the second post of Deputy Director (Tariff) which has already been approved "in principle" by the Government.

2. As per the orders issued in G.O.Ms.No.80, Energy (A1) Department, Dated: 19.8.2002, the under mentioned qualification and experience are required for the post of Deputy Director (Tariff).

> Post Graduate degree in Commerce or Chartered Accountant or Cost Accountant or MBA in Finance.

15 years experience in Accounting and Financial matters in large power sector or public utility service.

If sufficient number of candidates satisfying the above minimum qualification are available, they will be fit into Grade-be a vicinity eta lucavi fine il perme a lucavi monte Jamies sign D O letter No T N. E.R. C. ADIT J. P. Post Car

If Sufficient number of candidates are not available and there is a need to compromise on the above qualification / experience etc. such candidates will be accommodated in Grade II in the same post.

The Government after careful examination accept the proposal of the Tamil Nadu Electricity Regulatory Commission for opening the Second post of Deputy Director (Tariff) in the Tamil Nadu Electricity Regulatory Commission, subject to adhering to the terms and conditions stipulated in G.O.Ms.No.80, Energy (A1) Department dated: 19.8.2002, strictly.
